



3.2 Exposure Evaluation

From Council Recommendation 1999/519/EC table 2, the maximum power density is 10 W/m2.

Power density (S) is calculated by the following formula:

S =PG* Duty factor / $4\pi R^2$

P = Peak Power Input to antenna (Watts)

G =Antenna Gain (numeric)

R = distance to the center of radiation of antenna (in meter) = 0.20 m

Note:

- 1) P (Watts)=(10 ^ (dBm /10))/1000
- 2) G (Antenna gain in numeric) = 10[^] (Antenna gain in dBi /10)
- 3) Duty factor=1.0
- 4) π =3.142
